(3) SYLLABUS

This course provides an introduction to Political Economy. The main aim of the course is to help students to understand the most important economic laws of the capitalist economy and to examine some vital problems faced by modern economies such as economic growth, unemployment, inflation, etc. In the course we will be concerned with concepts such as market, price formation process, the law of supply and demand. There is also a reference to the great economists who have sealed the history of economics (Adam Smith, David Ricardo, Thomas Malthus, Karl Marx, Joseph Schumpeter, John Maynard Keynes, Milton Friedman) and to the major schools of economics that approach economic phenomena starting from different evaluative, ideological and political starting points.

Instructions for writing a research paper

Students are required to write a research paper related to the indicative titles below:

- Describe the life and work of one of the great thinker of Political Economy (for example, Adam Smith)
- The macroeconomic of Greece in the last five years (you can choose any period you wish, you can also compare the effectiveness of Greece with any other European country)
- Monetary policy and its types.
- The European Central Bank. Goals, tasks and strategies.
- Economic crises and their consequences.
- Elements and main controversies of modern macroeconomic consensus.
- The European crisis and the European responses
- The Greek economic crisis.
- The International Monetary Fund and the resolution of the economic crisis in Greece.

Students are invited to upload their work in the special electronic space that has been configured in the e-class until the deadline that will be clearly indicated in the e-class.

Be careful: All research papers must be uploaded in WORD format!!!!

Deadline: Date of exams

Students are required to write a research paper which should include the following elements:

- Cover page
- Contents
- Introduction
- Main topic Empirical Analysis
- Conclusions
- Bibliographical references

All research papers should follow a specific style that applies throughout the text both for the references inside and outside of the text.

The purpose, questions, methodology and the thesis of the work should also be clearly stated.

In any case, they must show that they possess the necessary knowledge that was taught in the course during the semester. This will be examined both from their arguments, the thesis statement and the quality of bibliographic references.

Attention: All texts will be automatically checked by the Turnitin similarity control system.
