EXCEEDING THE MAXIMUM DURATION OF STUDY (N. 4777/2021)

Please be informed that, according to par. 1 of article 34 and par. 4 of article 58 (N. 4777/2021) (Government Gazette 25/A/17.02.2021), the following are valid for the maximum duration of study:

1) For students admitted from the academic year 2021-2022 onwards:

The maximum duration of study in a first cycle study program with a minimum duration of eight (8) academic semesters (four (4) academic years), for the award of the degree, is this time increased by four (4) academic semesters (two (2) academic years).

The maximum duration of study in a first cycle study program with a minimum duration of ten (10) academic semesters (five (5) academic years), for the award of the degree, is this time increased by six (6) academic semesters (three (3) academic years).

Therefore, the above students must complete their studies up to:

- the academic year 2026-2027 (including the September 2027 exam period) for the four-year study Departments,
- the academic year 2028-2029 (including the September 2029 exam period) for the five-year study Departments (ΤΜΠΕΣ, ΤΜΣΠΣ, ΤΜΟΔ).
- 2) For the already enrolled students who during the academic year 2020-2021 had not exceeded the minimum study time (this concerns students who during the academic year 2020-2021 studied from the 1st to the 4th year (four-year study Departments) and from the 1st to the 5th year (five-year study Departments):

The calculation of the maximum duration of study starts from the beginning of the academic year 2021-2022 and extends to eight (8) academic semesters (four (4) academic years) increased by four (4) academic semesters (two (2) academic years) for the four-year study Departments and in ten (10) academic semesters (five (5) academic years) increased by six (6) academic semesters (three (3) academic years) for the five-year study Departments.

Therefore, the above students must complete their studies up to:

- the academic year 2026-2027 (including the September 2027 exam period) for the four-year study Departments,
- the academic year 2028-2029 (including the September 2029 exam period) for the five-year study Departments (ΤΜΠΕΣ, ΤΜΣΠΣ, ΤΜΟΔ).

3) For the already enrolled students who during the academic year 2020 - 2021 had exceeded the minimum study duration (this concerns students who during the academic year 2020-2021 studied in the 5th year and above (for the four-year study Departments) and in the 6th year and above (for five-year study Departments):

Extra study time is given, equal to the minimum duration of study of their Department four (4) academic years for four-year study Departments and five (5) academic years for five-year study Departments, starting the calculation from academic year 2021-2022.

Therefore, the above students must complete their studies up to:

- the academic year 2024-2025 (including the September 2025 exam period) for the four-year study Departments,
- the academic year 2025-2026 (including the September 2026 exam period) for the five-year study Departments (ΤΜΠΕΣ, ΤΜΣΠΣ, ΤΜΟΔ).
